## **Data Protection Procedure**

Sancton Parish Council complies with the Data Protection Act 1988 in the following ways -

- 1. Any personal data held by Sancton Parish Council will only be used in relation to the purpose for which it was obtained.
- 2. No personal data will be passed to third parties without the authority of the data subject, unless required to do so by law.
- 3. Council records, including personal data, are stored securely.
- 4. Personal data held by Sancton Parish Council will be periodically reviewed, and data no longer required will be deleted.

A request to have a copy of information held about you may be made to the Clerk, using the form attached. A fee of £10 (cheques made payable to Sancton Parish Council) should accompany any request. You must provide proof of identity, and of address, in the form of passport, photo driving licence, or birth certificate, and recent (past 3 months) utility bill, or bank statement. No requests from third parties to obtain someone else's personal data will be entertained, unless written authority, and proof of identity, from the individual concerned is received, or the agent has a legal form of authority (power of attorney) for the individual. The Council must be satisfied that this criterion has been met before releasing any information. We will provide you with information we hold about you within 40 days.
