

## **SANCTON PARISH COUNCIL: - "THE BURIAL AUTHORITY FOR THE PARISH"**

### **SANCTON CEMETERY CHARGES**

For the purpose of these charges "**Resident**" shall include a spouse, partner, child, parent and sibling of a person residing in the parish or an individual already buried or interred within the cemetery.

Charges applicable to a '**Non-Resident**' shall be the charges fixed by the East Riding of Yorkshire Council in respect of their services for Anlaby, Beverley Queensgate, Cottingham, Driffield, Hessle and Bridlington Cemeteries at the time of application. [Current prices are illustrated\*]
